The year was not as prosperous as 1902; there was a net loss of three members during 1903.

A mail carrier, attended a few meetings in 1903, 1904 and 1905; then commencing with 1906, took more interest in Club affairs; was Director in 1906; Secretary-Treasurer in 1907 and 1908. He discovered the only pane of part perf 2¢ Louisiana Purchase stamps. For several years, he was a partner of Edw.G.Hart#184 in the Cleveland Stamp Company. He finally dropped his membership in 1925; died 1948.

Special Meeting and Exhibition

On or before March 4, Professor Cushing invited the Club to hold a special meeting at the University Club. This invitation was accepted and a committee (Cushing, Crowell and Barnum) made arrangements for a stamp exhibit to be held at the meeting.

Fourteen members were present at the meeting, which was held on April 16. The exhibition consisted of five separate exhibits, each of twenty United States stamps. Crowell, Cushing and Langdon were the judges of the exhibits. The prizes were awarded as follows:

Change in Dues

At the January meeting, Crowell's motion (which had been laid on the table at the December meeting) was again discussed, and it was finally decided that there would be no initiation fee, but that dues would

be one dollar per year, payable in advance; and that dues for the first year must accompany application for membership. (Although the records are not specific as to prior practice, it is most probable that prior to 1903, applicants did not have to pay the first years dues until after they had been elected to membership).

Revision of the Constitution

Possibly on account of the changes in dues, it was decided to revise the constitution, and, at the May meeting, President Schneider appointed a committee (Crowell, Langdon and Good) to draw up a revised constitution. Barnum was added to the committee in October. In December, the committee finished its work, and Crowell read the revised form at the meeting of December 17. The minutes state, "After considerable discussion and a few slight changes the Constitution was adopted as read"; but unfortunately do not specify just what changes were made. The new constitution was printed early in 1904, with a roster of Club members.

American Philatelic Association

The Club took no part in A.P.A. affairs during the year. The number of A.P.A. members in Cleveland according to the A.P.A. Year Book for 1903 was only four*, the smallest number since the Club had been established. Only three of the four were members of Garfield-Perry.

*They were W.H.Barnum, T.H.Bierman, Henry C.Crowell and George H. Worthington.
