## Changes in Membership (continued)

The new members were partly Cleveland residents and partly out of town, as follows:

- Otto C. Reymann was a resident of Alliance, O., who hater moved to Pittsburgh, Pa., He was a member until he resigned in 1912.
- Dudley J. Hard was Secretary-Treasurer of the Cleveland Light and Power Company. He took no part in Club activities; resigned in 1909.
- Eustace B. Power manager of the New York branch of Stanley Gibbons & Co. was a visitor on May 16,1907, exhibited some choice stamps and made a talk; attended another meeting in 1909; resigned at the end of 1910.
- otto F. Moses, age about 22 in 1907, was a bookkeeper, later an insurance man. He took a very active interest from the start; attended seven meetings in 1907; eleven in 1908, etc. He was the 22d President of the Club in 1922 and 1923, and served on many important committees. Resigned in 1929.
- william A. Osborn was a chemist. He attended only one meeting -- in 1907 -- but continued his membership for over three years, until he resigned in 1910.
- Eben S. Martin was a stamp dealer located in Chicago in 1907. He moved to Plano, Illinois in 1908; to Columbus, Ohio in 1910. At one time, he published a daily philatelic newspaper. A colorful character. He was dropped in 1916.

George Kieferle was a commetcial traveler.

There is no record of his having attended any meeting of the Club. He resigned in December, 1908.

Joseph O.Prescott was a bookkeeper for the Saginaw Bay Company when he first joined the Club in 1894. He took a leading part in the activities of the Club; was Vice President in 1897, and served as our eighth President in 1898 and 1899. Although the record is incomplete, it is likely that he was dropped from membership about the turn of the century. After his reinstatement, he attended two meetings; both in 1908; and resigned in 1910.

John G. ERCK was a department manager of the May Company. He attended two meetings in 1908; none thereafter - probably because he moved to New York City about the end of 1908. He was dropped from the rolls in September, 1910.

Reginald G.A. Phillips was assistant General Manager of the American Multigraph Compnay. There is no record of his having attended any meeting of the Club; but he continued his membership almost three years until he resigned in September, 1910.

CHARLES L.PACK was a philatelist of world-wide renown when he was elected to honorary membership on November 7, 1907. There is no record that he attended any Club meeting; but his collections were frequently exhibited at the Club. (Canada, November 21,1907; Spain, March 4, 1909; another collection, March, 1910; another March, 1911; another, March 20, 1915). He died in June, 1937. A.W.Batchelder, a stamp dealer of Boston, Mass., was elected to membership on December 19, 1907. He attended a Club meeting on February 20, 1908, and displayed a lot of rare stamps, and made a short talk on the Boston club. On September 16, 1909, he attended anorher meeting, and made a talk. In 1911, he (and E.M.Carpenter) donated a copy of C.A. Howe's book on Canada to the Club library. He did not attend any meeting after 1909; but retained his membership in the Club until 1917 when he resigned.

Paul T. Skove was a young stenographer, residing at 2195 Woodland Avenue, Cleveland, in 1907. He attended five meetings in 1908; but resigned before the end of that year, his resignation being accepted on November 15, 1908.

On November 5, 1937 -- almost twenty-nine years later -- his application for reinstatement was posted; and, on January 7, 1938, he was reinstated as member No. 662.

Edward C. Schweizer, a commercial traveler, (age cloud residing at 572 East 103d Street, Cleveland, was elected to membership on December 19, 1907. In the following year, he attended six Club meetings; but there is no record of his attending any meeting thereafter. Some time later, he moved to White River Jct., Vermont; but he continued his membership for several years thereafter -- until 1922.

It was agreed to accept the offer and hold the club's meetings at these rooms 731 Williamson Bldg. for the balance of the season." The April 4th meeting was held at 731 Williamson Building; but the next meeting - that of April 18th - was held at 1301 New England Building, as was the meeting of May 2d. at which meeting it was announced that the Club had secured the permanent use of rooms at 1301 New England Building for future meetings.

## Changes in the Club Rules and Regulations

Bruce, Barnum, Good and Jenkins, was appointed at the meeting of October 3d.

At the December 5th meeting, the Committee reported, and, on motion of Mr. Bruce, duly seconded, Secretary Weigel was ordered to purchase fifty copies of the December 1907 issue of the Chicago Collectors' Monthly (containing a sketch of Garfield-Perry) to be used for distribution in interest of the Club.

## Official Club Organ

In March, the question of securing an official organ was discussed at the Club meeting; and ke the Secretary was instructed to ascertain the rates of the Chicago Collectors' Monthly for that service.

At the meeting of April 18th, the Chicago Collectors' Monthly was adopted as the official journal of the Club "subject to terms as offered by the publishers" (The rate required was sixteen cents per year for each member of the Club).

The question of properly housing the club library was evidently und r consideration in 1907, and apparently no satisfactory solution was found at that time. # CLEVELAND BOYS INDUSTRIAL EXHIBITION

In the spring of 1907 the different social settlement organizations in Cleveland, in conjunction with the Cleveland Public Library, put on an exhibition in Cleveland Grays Armory, of collections and work of various kinds done by school boys. Alvin Good was chairman of the "collection department", which included stamps, coins, butterfiles, shells, etc. Legrand French assisted him. An admission fee of 10¢ was charged. The show was a great success, and did much to stimulate interest in stamp collecting. (For Alvin Good's account of this exhibition, see page 85 of his "The Life and Atentures of a Philatelist")
