Jay Stotts – Jay is a lifelong collector who has been exhibiting since 1980. His national exhibits have covered many disciplines including traditional, postal history, aerophilately, thematics, first day covers and post cards. He was accredited as an APS philatelic judge in 1989 and was awarded the AAPE's 2019 Bernard Hennig Award for judging excellence. He is a former president of both the Bureau Issues Association (BIA) and the United States Stamp Society (USSS). While living in the Cleveland area, he served as the 1992 March Party show chairman.



Rob Henak – Rob started collecting stamps in 1993 when he discovered the club meeting was 35 minutes closer than the coin club meeting. His list of exhibiting credentials is long, having won every award from a local certificate to WSP large gold. He enjoys all exhibits, but especially likes topical / thematics and illustrated mail. Rob offers exhibiting advice through the AAPE Critique Service and authored the Exhibiting 101 column for *Topical Times* from 2017 to 2022.



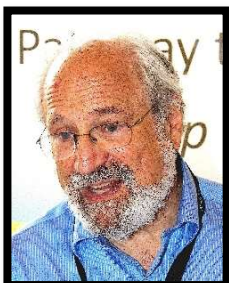
Steve McGill – Steve has a collector since childhood though with a long hiatus during early family and business development years. He returned to collecting the late 1990s with collections of Great Britain and Colonies, China, Monaco, Vatican City and a few remote areas such as FrS & AT, Faroes and Svalbard. He has specialized in the British Machin definitive series and exhibits actively in the U.S. and internationally. He has also contributed many articles to the philatelic press and teaches at the APS Summer Seminar event.



Stephen Rose – Steve has been collecting again since 1972, when his mom threatened to throw out his childhood stamp album stored in the attic. (She did throw out the baseball cards, worth a lot more than the stamps.) He's now retired after 30 years as a pilot and then JAG in the Navy and 15 years as a lawyer with NATO. Steve's been an exhibitor since 1988 and judge since 2012. He has developed collections of Brazil, U.S. classics, and British West Indies.



Dan Walker – Dan is an accredited international judge, an APS 50+ year member and member of many other philatelic organizations. He won the Champion of Champions for his traditional Grenada exhibit, has earned the Luff Award, and signed the Royal's Roll of Distinguished Philatelists. He served on the APS board as secretary and member-at-large. He continues to collect and exhibit a variety of subjects including Indian Feudatory States and early United States revenue stamps.



Michael Bloom – Michael has a long philatelic bio including serving as an APS director and Chair of the Membership Committee. This will be his fourth apprenticeship as a judge, so he will be accredited shortly. Michael specializes in the stamps of Latvia and Guatemala and has co-authored or edited books on both subjects. He is also on the Boston 2026 and PIPEX show committees.
